

4. Consider and take appropriate action to accept or reject bids on replacing windows at Courthouse;

The Commissioners Court may take action on any of the above items. The Commissioners Court may meet in Executive Session on any of the above items as authorized by the Texas Open Meetings Act, and pursuant to Government Code 551, sub-chapter D.



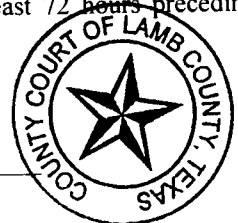
