COMMISSIONERS COURT OF LAMB COUNTY, TEXAS**



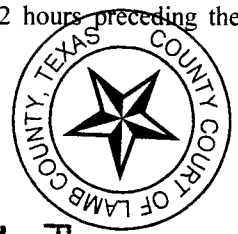
