

INTERLOCAL AGREEMENT

OLTON INDEPENDENT SCHOOL DISTRICT

AND

LAMB COUNTY

AND

CITY OF OLTON

This Interlocal Agreement (“Agreement”) is entered into on December 14, 2018 (“Effective Date”) in accordance with the provisions of the Interlocal Cooperation Act (Chapter 791 of the Texas Government Code) by **Olton Independent School District (“ District”)**, and **Lamb County (“County”)**, and **City of Olton (“City”)** hereinafter the Parties.

WHEREAS, the District is a political subdivision of the State of Texas and derives its status under Article VII of the Texas Constitution;

WHEREAS, the County and City are also political subdivisions of the State of Texas

WHEREAS, the District, County, and City have a common public interest the transfer of land ownership to the District for the purpose of improving baseball facilities that are utilized by the District and the Olton community;

WHEREAS, the City owns real property located at Block 140 Lot 10, Olton, Texas (“Property”);

WHEREAS, the County owns real property located at Block 140 Lot 12, Olton, Texas (“Property”);

WHEREAS, the District plans to acquire the Property from the County and the City to improve baseball facilities utilized by the District and the Olton community;

NOW THEREFORE, the District, County, and City agree as follows:

PURPOSE: This Agreement is for the District to purchase Block 140 lot 10 from the City and Block 140 Lot 12 from the County in consideration for the payment of \$100 per lot.

NOTICES: Any notice or statement required or permitted to be delivered by one of the Parties to this Agreement to the other shall be deemed delivered by depositing same in the United States mail, certified with return receipt requested, postage prepaid, addressed to the appropriate party at the address show below, or at such other address (or addresses) provided by the parties to each other:

APPLICABLE LAW AND VENUE. This Agreement is made, and shall be construed and interpreted under the laws of the State of Texas, and venue to enforce or interpret any aspect of this Agreement shall lie in Lamb County, Texas.





INTERLOCAL AGREEMENT

OLTON INDEPENDENT SCHOOL DISTRICT **AND** **LAMB COUNTY** **AND** **CITY OF OLTON**

This Interlocal Agreement (“Agreement”) is entered into on March 1, 2019 (“Effective Date”) in accordance with the provisions of the Interlocal Cooperation Act (Chapter 791 of the Texas Government Code) by **Olton Independent School District (“ District”)**, and **Lamb County (“County”)**, and **City of Olton (“City”)** hereinafter the Parties.

WHEREAS, the District is a political subdivision of the State of Texas and derives its status under Article VII of the Texas Constitution;

WHEREAS, the County and City are also political subdivisions of the State of Texas

WHEREAS, the District, County, and City have a common public interest the transfer of land ownership to the District for the purpose of improving baseball facilities that are utilized by the District and the Olton community;

WHEREAS, the City, County, and District collectively own real property located at Block 140 Lot 9, Block 140 Lot 11, Block 140 Lot 12, and Block 140 Lot 13, Olton, Texas (“Property”);

WHEREAS, the District plans to acquire sole ownership of the Properties from the County and the City to improve baseball facilities utilized by the District and the Olton community;

NOW THEREFORE, the District, County, and City agree as follows:

PURPOSE: This Agreement is for the District to purchase the City’s share of Block 140 Lot 9, Block 140 Lot 11, Block 140 Lot 12, and Block 140 Lot 13 at \$50 per lot. This Agreement is also for the District to purchase the County’s share of Block 140 Lot 9, Block 140 Lot 11, Block 140 Lot 12, and Block 140 Lot 13 at \$50 per lot.






