

 - (f) Consider and take appropriate action on departmental reports;
4. Consider and take appropriate action on policy for sponsored aliens applying for Indigent Health Care Services;
5. Consider and take appropriate action on appointment of Family Consumer Science Agent in Extension Office;
6. Consider and take appropriate action on appropriate fee's in the County & District Court's;
7. Executive Session pursuant to Government Code Section 551.074 to discuss personnel issues;
