The FMH Foundation and the Recipient agree to the following terms as a condition of this grant.

If the Recipient has reason to believe that the grant funds cannot be or continue to be expended for this purpose, the Recipient will notify the FMH Foundation immediately, in writing. With advance approval of the FMH Foundation, Recipient may publicize this grant acknowledging support from the FMH Foundation in print, broadcast or digital media, utilizing the Foundation's logo located at www.fmhfoundation.org.

If Recipient breaches the terms of this contract and such breach is not waived in writing by the FMH Foundation, then the Recipient shall return all grant funds to the FMH Foundation within 30 days after such breach. All matters regarding compliance with this contract shall be decided conclusively by the FMH Foundation.

Recipient agrees to submit interim progress reports (as requested) and a final report at the completion of the project or purpose for these funds. Recipient agrees to submit these reports, with additional documentation as requested, electronically through a link provided by the Foundation.

Recipient certifies that the organization's tax status, as indicated in the Recipient's Grant Application, is still valid and that the Recipient is not aware of any pending or threatened challenge to its classification.

The recipient agrees to provide a signed, written acknowledgement that includes the organization's name; the date the grant was received; the grant amount; and a statement that no goods or services were provided by the organization in return for the grant. If that is the case, a good faith estimate of the value of goods or services should be stated.

By signing this Contract, Recipient confirms: (1) that the signatory is a duly authorized officer of the Recipient; (2) the governing body of Recipient authorized the original Grant Application; (3) the signatory has read and understands this Grant Contract; and (4) the Recipient accepts the terms of this Grant Contract.
