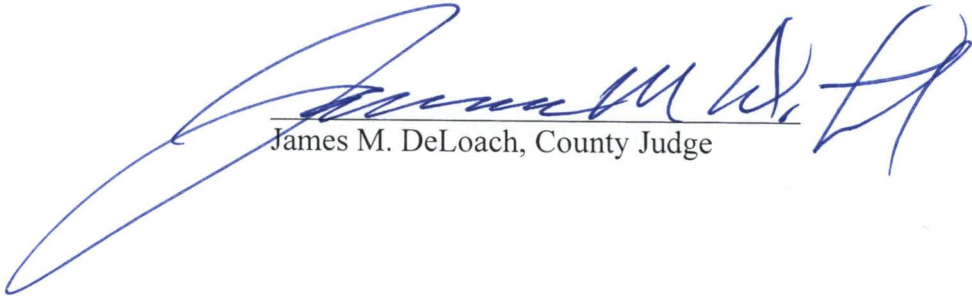


BUDGET TRANSFER AUTHORIZATION
