## INTERLOCAL AGREEMENT AMENDMENT

It is mutually understood and agreed by and between **Lubbock County, Texas** and **Lamb County** as parties to an **agreement for inmate housing services** which has been in effect since the 8<sup>th</sup> day of June, 2021 to waive any limitations on modification of the original **Agreement** for the sole purpose of modifying said **Agreement** as follows:

Article 3.01 in the original **Agreement** is hereby amended to allow for an additional one year term. The term of the **Agreement** is hereby extended for an additional one (1) year, commencing June 9, 2022 and maturing June 8, 2023.

These modifications shall become effective on the date of execution. All other terms and conditions not hereby modified shall remain in full force and effect.


