

8. Budget work session;



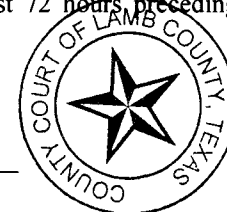
