Non-Exclusive License and Services Agreement

THIS ADDENDA is entered into and executed by and between LAMB COUNTY, TEXAS ("COUNTY") with administrative offices located at Lamb County Courthouse, Littlefield, Texas, and Local Government Solutions, L.P. ("VENDOR"), having its principal place of business at 2693 Hwy 77, North, Suite 2100, Waxahachie, Texas 75165:

WHEREAS, the Commissioners Court of the COUNTY has determined that it desires to amend the existing contract for data processing services to add an additional full licensed user to the office of the County and District Attorney; and

WHEREAS, the COUNTY is a willing participant in this Addendum and is bound by the existing Agreement with the VENDOR hereinafter referred to as Contract # LGS20-0023 and entitled Non-Exclusive License and Services Agreement (NLSA), which is on file in the Lamb County Clerks Records. 


